#### **Inspired Planning**

The Tau Society is University of Maryland St. Joseph Medical Center's Legacy Society. The Society is named for the letter in the Greek and Hebrew alphabets, and, more importantly, a symbol which St. Francis of Assisi cherished. The Tau Society honors a committed and special group of individuals who choose to include UM St. Joseph Medical Center in their estate plans.

#### Membership In The Tau Society

Through their gifts and gift commitments, Tau Society members provide an assurance that the medical center will always be capable of responding to the changing health care needs of the patients we serve. Membership is offered to all individuals, regardless of their capacity to give, who indicate that they have made a planned or deferred gift to the Foundation. Only a statement of intent to leave a gift to University of Maryland St. Joseph Medical Center Foundation is required; however, if you so choose, we kindly ask that you share with us your intended planned gift vehicle and current estimated value to ensure we steward your gift appropriately.

- Including a charitable bequest in your will is one way to make a lasting gift to UM St. Joseph.
- Naming the medical center as a beneficiary of your retirement plan is easy to do and is a way to make a gift that may not be possible during your lifetime.
- Life insurance provides a simple way for you to give a significant gift to the medical center, with potential tax benefits that you can enjoy during your lifetime.

### **GIFT PLANNING** *instruments and opportunities*

Below is information about the most frequently used planned gifts made by donors to support the UM St. Joseph Medical Center. We are extraordinarily grateful to everyone who chooses to leave a legacy of support to our hospital.

**Bequests:** Naming UM St. Joseph Medical Center as a beneficiary in your will or trust can be a very satisfying way to ensure support of the hospital for future generations of patients and health care providers. Bequest gifts make up a very significant percentage of all planned gifts received by our hospital. The bequest can also specify a dollar amount or a percentage of your estate as the gift amount.

Life Insurance and Retirement Plan Beneficiary Designations: You may also support UM St. Joseph Medical Center by naming it as the beneficiary or contingent beneficiary of life insurance policies or retirement plans. These instruments can provide resources that support specific areas, or the greatest need of the hospital, and we are especially grateful for these thoughtful gifts.

### More about GIFT PLANNING

Additional gift planning options: You can also support UM St. Joseph Medical Center by making a life-income gift, often attractive to donors who wish to ensure an income stream from their assets during their lifetime. By creating a Charitable Gift Annuity that names UM St. Joseph Medical Center as its beneficiary, you can ensure an income stream for life, based on your age and the amount of the initial gift. You can also use Charitable Remainder and Charitable Lead Trusts to transfer assets to the hospital through annuity or lead trusts.

We encourage our supporters to inform us of planned gift intentions for several reasons. By having a conversation with us about how you want your gift used, we can document how you want your gift directed. In addition, we can also thank you for thoughtfully planning a gift designated to UM St. Joseph Medical Center.
